<u>Full Description</u>: Sliced Carrots are prepared from clean, sound carrots packed in water with salt and calcium chloride. The product is packed in hermetically sealed containers and sufficiently processed by heat to assure preservation.

Quality Characteristics:

Style	Sliced – carrots, which are cut into slices not thicker than 1/4".
Quality	Must meet USDA Grade A. Must comply with the US Standards for Grades of Canned Carrots, with modifications noted within these specifications.
Color	Shall be bright and typical uniform yellow-orange color. Presence of green units does not more than slightly affect appearance or eating quality. Optimal is deep orange color.
Size	Sliced – shall not be more than 1/4" in thickness. In 90 percent, by count, the slices that are most uniform in diameter, the diameter of the slice with the greatest diameter is not more than twice the diameter of the slice with the smallest diameter.
Maturity	Must be tender but not mushy and possess a fine and even texture, free from stringiness. Units must have a clean cut appearance and show no more than a trace of sloughing in the brine and which does not noticeably affect appearance or eating quality.
Defects	Sliced – not more than 3% by weight defective units; not more than 5% by weight are crown or small taproot cuts.

Physical Characteristics:

Seneca Foods Corporation produces our products to meet a target specification at the time of production. Due to the nature of our commodity products, there are factors such as product maturity, variety, moisture level, and the growing conditions of each particular field which may cause a deviation from the target specification as the product cycles through the shelf life.

General Information:

Seneca Foods Corporation manufactures in accordance with the Good Manufacturing Practices (21 CFR, Parts 110 & 113). The finished product and packaging conforms with the provisions of the Federal Food, Drug and Cosmetic Act as amended, to all applicable USDA regulations, to the state regulations in which the facility is located and is fit for human consumption.

All of our production facilities have a HACCP program, but at this time there is not a requirement for Low Acid Canning Facilities. Our HACCP Plans are available for review at each location.

Seneca Foods is in current compliance with the Food Safety Modernization Act, signed in 2011. While several provisions of the act are still in review and development stage, we will continue to monitor and update our programs as needed. All of our facilities have re-registered as part of this act.
